Article 1

Either Party may request changes to and/or cancellation of this Memorandum of Understanding by giving six months' prior notice. In that case, the actions in hand shall be brought to completion.

Article 6

The Parties agree to place information about this Memorandum of Understanding on their websites and in promotional materials along with the permission to use the logo of the Partner for the purpose of the promotion of this cooperation.

Article 7

This Memorandum of Understanding is made in English in two identical copies, each copy being deemed authentic. Each Party shall receive a copy.
