### **Abstract Guidelines**

All materials are submitted in the form of abstracts.

**Text formatting.** Text editor is an MS WORD document. The abstract length must be between 3 to 5 pages including references, tables, diagrams, etc., in 14 Times New Roman font, with a 1.5 interval. The margins: left – 3 cm; top, right and bottom – 2 cm. (*See Appendix 1 below for the abstract sample*). Abstracts must be provided in Ukrainian or English. References must be arranged in alphabetical order and align with the DSTU 8302:2015 standard.

The content of abstracts must be relevant to the thematic areas of the conference. Abstracts that are not relevant to the conference will not be accepted or returned to the authors.

Abstract manuscripts may be edited by the organizing committee if necessary.
